## 2020 DELEGATE FORM

The Annual Meeting of The Cat Fanciers' Association, Inc.® will be held at the Davenport Grand Hotel, Spokane, Washington on Friday, June 19, 2020.

Each member club that has been in good standing for not less than fifty (50) days immediately prior to an Annual or special meeting is entitled to one (1) vote.

A delegate may be a member of ANY member club, not necessarily a member of this club. *PLEASE NAME A DELEGATE WHO WILL ATTEND THE ANNUAL MEETING.* If a delegate assigns a club vote to a proxy, the club will have no control over the vote of the proxy on matters brought to the floor of the meeting.

Delegates or proxies may not be Officers or Board Members of any association or organization organized for purposes similar to those of this association. A delegate may appoint a proxy from the members of any member club. No person shall cast as a delegate and/or proxy more than two (2) votes.

When the Central Office has received delegate information totaling two (2) votes for any one delegate, any further designation of votes to that person will be flagged for reconciliation prior to the Annual Meeting.

**There are four (4) options for submitting the delegate information:**

**Online:** Complete and pay [Here](#).

**Email:** Email completed form to Amber Goodright, agoodright@cfa.org. The form must be attached and the sending email address **must match the email address of the club secretary on file** in the Central Office.

**Regular Mail:** Mail the completed form to the CENTRAL OFFICE **postmarked** no later than Friday, May 1, 2020.

**Fax:** Fax completed form to 330-680-4633 by 11:59PM Eastern Daylight Time on May 1, 2020.

Delegate information provided electronically must be received no later than 11:59PM (Eastern Daylight Time) on May 1, 2020. Mailed forms must be postmarked by May 1, 2020.

**Clubs not meeting the deadline will be INELIGIBLE TO VOTE AT THE ANNUAL MEETING.**

### DELEGATE REGISTRATION FEE

As stated in Article IV – Section 4 of the CFA Constitution, “....each delegate or proxy to the Annual Meeting shall pay a registration fee of forty dollars (\$40.<sup>00</sup>) for each vote carried....”
